Please follow the instruction carefully and submitted the same after close scrutiny of details provided by you. in case if you are unable to submit form online the download the entry form and email it on sociocorpcsr@gmail.com along with passport size photo of the director, poster, still photographs of the film, nomination form, registration form, NOC and payment receipt in softcopy.
2. For programming consideration, the festival accepts via Google link, Vimeo link of your film or full HD-DVDs/USBs without watermark only. The SCSRfif will not consider trailers or promos for selection purposes.
3. Two DVDs/ USBs must be properly labelled with the Film Title, Director's name and contacts, Year of production, Duration, format and subtitled in English and without any watermarks.
4. Films will normally be screened in their original language/version. Films in language other than English must have subtitles in English. Films that arrive without subtitles, or with subtitles other than in English, where such subtitles are required, shall not be screened in the SCSRfif.
5. For submissions coming from outside India, the packages must be marked, "For Festival & Cultural Purpose only, No Commercial value".
